
Going with the flow

We are excited to inform you that we have shifted the headquarters to Islamabad, amidst the beautiful Margalla Hills in D-12 Markaz. It was indeed a daunting task but kudos to our team which has pulled it off in the best possible manner. Our office is operational and the team is working in good spirits. Our previous office at Karachi is still in place but is now working as the Regional Office.

Due to these chaotic and unsafe times, we are not dealing publicly. Our team has been working online from home except the administrative staff. PCATP looks forward to welcoming you all at our head office once things come back to normal. However, do not hesitate to contact us at our landline numbers or via email.

Acting Right Against Wrong

PCATP has issued 10 showcause notices to those practicing architecture or town planning illegallyand their registration has been suspended by the Executive Committee.

CLIMBING UP THE LADDER

PCATP has been engaged in more than fifty correspondences in this term so far. We continue to play our role diligently in protecting the rights of our registered town planners and architects. Many of our requests are not met with positive responses but we continue to ensure that we open avenues of opportunities for our architects and town planners. Do not get disappointed because we have a lot of accomplishments to share, a few bigger ones are highlighted below;

- Gilgit Development Authority has agreed to allow PCATP registered architects and town planners in Gilgit Master Plan 2040.
- PCATP registered town planners are now eligible for providing consultancy services For Preparation of Master Plan ForDalbin Town and outline development plan for Nokundi, Taftan&Chaghi Towns, District Chaghi.
- The Institute of Chartered Accounts of Pakistan revised its corrigendum and included the name of PCATP along with PEC in their advertisement.
- Chief Minister Punjab responded to providing grant of Technical Allowance for Architects and Town Planners working in all Provincial Departments and Agencies of their respective provinces.
- Letter sent to all Provincial Chief Minister's for the grant of Technical Allowance for architects and town planners working In all provincial departments and agencies of their respectiveprovinces.
- Letter sent to all Chief Secretaries, Local Governments, Cantonment Offices, PDA, C&W Departments, and Tehsil Councils of all provinces and to Civil Aviation Authority to only allow registered architects/town planners work in all architectural/town planning departments and to revise the PPRA rules to change the criteria from PEC to PCATP registration for architectural/town planning related jobs.
- Prime Minister Secretariat through Ministry of Federal Education and Professional Training responded to HEC on

the letter sent to Prime Minister subjected as Appointment of Non-Architects/ Town Planners in various government departments/development authorities and Educational Institutions in contravention of PCATP Ordinance IX of 1983.

- 18 licenses were cancelled by Municipal Committee Lalamusa and Kharian who did not have registration with PCATP.
- SPPRA responded on our letter with reference to EOI for selection of consultants for Architectural Design with PEC registration.
- Corrigendum issued by NIP (National Industrial Parks) for inclusion of PCATP along with PEC.
- PCATP name inserted with PEC for the hiring of consultant in Balochistan Coastal Development Authority.
- Secretary Local Government & Community Development Department, Punjab issued letters to all Municipal and Tehsil Councils to abide by the PCATP laws.
- DHA Lahore and Karachi showed consent towards getting PCATP's help in amendment of their construction rules and regulations.
- Meetings with FBR, 2020 requesting elimination of withholding taxes and provincial sales taxes in the Construction Policy 2020 to facilitate the construction industry and the profession.
- Inclusion of role of Architects and Town Planners in the proposed establishment of CIDB 2020.
- Inclusion of PCATP in Naya Pakistan Development Housing Scheme.
- 79 notices were sent to all cantonment boards, DHAs and development authorities to ensure compliance with PCATP Ordinance and discontinue the practice of re-registering architects if they are in possession of an upto-date and valid PCATP registration. Only Swabi Development Authority and Walton Cantonment Board responded. A second wave of notices is issued recently to those who have not responded.
- HBFC revised its addendum for hiring of consultancy services of strong room and rehabilitation and inserted the name of PCATP along PEC.

POLISHING The skills

PCATP has assigned CPD points to around 25 various lecture series, conferences, seminars etc. held in Karachi, Islamabad, Lahore, Peshawar, Jamshoro and even Dhaka.

It recently assigned CPD points to the webinar series held recently by the Institute of Architects Pakistan-Rawalpindi-Islamabad Chapter, featuring Ar. Yasmeen Lari and others.

CPD points have also been awarded to the webinar series organized by the Institute of Architects Pakistan in collaboration with Aga Khan Award for Architecture (AKAA), presenting the winning projects and their Architects in discussion with the Steering Committee, Master Jury and Reviewers from the Aga Khan Award for Architecture Cycle 2017-19.

The Executive Committee is putting efforts in developing a cell phone application exclusively for CPD scheduling, attendance and record keeping. The Executive Committee is likely to keep the implementation of CPD requirements on hold until the application is fully functional.

PCATP also encourages all the architects to join the remarkable online sessions consisting of 9 webinars and 7 lecture series on sustainable urbanization organized by Commonwealth Association of Architects centered on Sustainable Urbanization.

These webinar/lecture series from 24th June to 31st August provide an excellent opportunity for all the architects to make the best of this time.

ACING THE ACE

As per amended Bye-laws 2018, a graduate architect (2014-2019) of 2014 intake or later will have to go through Architecture Competency Examination (ACE) for obtaining license from PCATP.

All earlier graduates applying for registration after 31st December 2019 will also have to go through ACE for getting license from PCATP.

PCATP will issue the graduates with the registration certificate which will allow them to either get employed or continue higher studies. However, the license to sign the submission drawings or building plans will only be issued after acquiring one year of practical experience and clearing ACE.

Considering the current situation in the country, the Council is still deliberating if any change in applications dates of this examination is required or not. Log on to our website for the ACE syllabus ad start preparing now!

SURVEYING For Better

Survey regarding status of Architecture and Town Planning Profession Status in Pakistan

The Pakistan Council of Architects and Town Planners (PCATP) organised a survey between October 2019 and January, 2020 with the approval of Executive Committee.

The main objective of this study, the first of its kind in Pakistan, was to map the current scenario of the architecture and town planning profession in Pakistan and compile of data for future guidelines. The results of the survey will be discussed in the AGM and will also uploaded on the official website of PCATP.
